

A BRIEF PROFILE OF MR JOSHA OLUDAYO ADEOYE

Joshua Oludayo Adeoye is a widely exposed Chartered Secretary/ Administrator, Corporate Governance Expert and Human Resource Practitioner with a very high level of versatility. He obtains the Nigeria Certificate in Education(NCE) in Accounting and Distributive Education(with Distinctions) from the College of Education, Obafemi Awolowo University, Ile-Ife in 1992. He proceeded to the University of Ibadan, Consultancy Services Unit, where he obtained both Diploma and Advanced Diploma in Business Administration, with Distinctions in the years 1997 and 1998 respectively. He capped it with a Post Graduate Diploma in Financial Management at Upper Credit grade in the year 1999 from the same University.

For his professional qualifications, Joshua obtained the Professional Diploma in Corporate and Public Administration(Degree equivalent) awarded by the Institute of Chartered Secretaries and Administrators of Nigeria in the year 2001. Mr Adeoye has been an Educational Administrator for well over 14 years before joining Alpha Genasec Limited, the secretarial arm of Baker Tilly Nigeria, an international firm of Chartered Accountants, in the year 2008, first as an Assistant Company Secretary and later promoted a substantive Company Secretary/Secretarial Manager from October, 2011 to October, 2017.
